My name is Alexis Moore I am a high-risk victim of domestic violence, cyberstalking and stalking in California. I am seeking help from the CPEDV.

I appreciate any help the CPEDV and their vast network can offer.

The matter is in the El Dorado County Superior Court. The hearing to end the lifetime restraining order was January 10, 2020. I was successful in defending my lifetime restraining order which in turn opened the door for me to be able to sue the batterer/stalker lawyer for abuse of process.

I spoke with the Battered Women's Justice Project representative today by phone, they suggested I reach out to you CPEDV. Their staff attorney concurred my case for abuse of process against a batterer/stalker lawyer a civil tort, will be 1<sup>st</sup> in the nation. Therefore my case has potential to open doors for victims of domestic violence and stalking like myself to sue predatory lawyers which will serve as an valuable homicide prevention tool.

Press assistance: Often times the media exposure for matters such as this serves as a positive tool – my attorney is Geoffrey Evers of the Evers Law Group in Sacramento, CA. He suggested I contact the media about my case, I have but so far not one TV or print news outlet will report on this matter. May be with the help of CPEDV press department and a press release this will change.

We cannot have victims of DV and stalking scared silent by unscrupulous lawyers and batterers.
